Shands Jacksonville Medical Center, Inc provides quality healthcare regardless of race, creed, sex, national origin, handicap, age or ability to pay Although reimbursement for services rendered is critical to the operation and stability of the Medical Center, it is recognized that not all individuals possess the ability to purchase these essential medical services Our mission is to serve the community with respect by providing healthcare services and health education The following services and activities are provided where the need and an individual's inability to pay coexist free care and/or subsidized care, care provided to persons covered by governmental programs at or below cost and health activities and programs to support the community Shands Jacksonville is a 696 bed not-for-profit academic medical center affiliated with the University of FLorida There are more than 330 nationally recognized faculty physicians working with over 350 hospital-based and private practice community doctors The University of Florida has over 300 full-time residents at Shands Jacksonville Twenty-five percent of the education of College of Medicine students takes place here Shands Jacksonville has a Level 1 Trauma Center and is home to the regional perinatal ICU, the highest level of neonatal intensive care Our physicians specialize in high-rnsk pregnancy and complex pediatric illnesses The Florida Poison Information Center is also located on campus,covering 42 counties and a resource for over six million residents, 151 healthcare institutions and 121 EMS (Emergency Medical Service) agencies Over 12,000 people were exposed to the poison prevention and safety messages, including children K through 12th grades Shands Jacksonville together with University of Florida has developed several Centers of Excellence The Cardiovascular Center, The Neuroscience Institute, The Bone and Joint Institute and the UF Cancer Center These centers bring together interdisciplinary teams using all the resources of the academic medical center Shands Jacksonville is a leader in providing both unique and essential clinical programs and services, as well as in promoting good health with preventative care, screenings and health education programs that reach residents where they live and work The hospital hosted or participated in over 150 Health Fairs and other special events and performed blood pressure, HIV, cholesterol, stroke assessment, pregnancy, blood sugar and glaucoma screenings In addition, total number of employee volunteer hours donated to the community exceeded 35,000 Shands Jacksonville also has an active community affairs department committed to improving the quality of life through leadership, networking, collaboration and education The community affairs department serves a defined area of Jacksonville's urban core that represent 40 percent of the African-American population in Jacksonville
