Individuals that are referred to the organization are given food, clothing, furniture, and other household goods to get them started once they arrive here. Apartments are rented and rent is paid on their behalf by the organization. The Refugees do not receive cash until they have established a good track record of work and adapting, then they can qualify for employment bonuses. The organization also provides training to help Refugees adapt, such as teaching them the English language and other usefull skills to help them succeed.
