Funding to support student financial aid and scholarships to enable those students to attend college who are both capable and/or have financial need. These scholarships include merit scholarships awarded to students in the Eastern Kentucky University Honors Program as well as funding for students who have financial need. This source of this funding is primarily from earnings and return on endowment funds where the donor has designated the use for the intended scholarship purposes for merit scholars and students who have unmet financial need in order to be able to attend college.

4b (Code:) (Expenses \$ 2,074,488 including grants of \$) (Revenue \$)

Funding to support programs and faculty professional development in addition to full or partial funding of academic chairs through earning and return on endowment funds. The ability to have faculty chairs furthers the quality of the educational experience by funding educational and scholarly activities which is beneficial in bringing more to the classroom. Further professional development more broadly for faculty results in a similar result - enriching the overall educational experience. Additionally, these professional development opportunities serve to allow faculty to keep up to date in their respective disciplines and to collaborate with others in furthering their knowledge base.

Funding to support alumni activities in order to develop support for Eastern Kentucky University through annual and long-term charitable giving. These activities keep alumni connected to Eastern Kentucky University, thus assists in developing loyalty and both financial and other assistance in furthering the teaching mission of the University in educating students. These events are held in various regions in the nation and have resulted, over the past few years, in alumni who are much more engaged in the life of the University and who have been more financially supportive of its students and programs.
