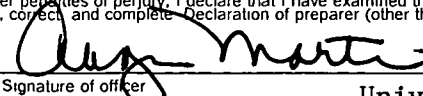

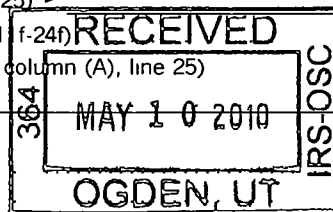

Each job grade has a salary range with a minimum, a midpoint and top of the range.

2) Definitions

For the purposes of this policy, the following definitions apply:

- a. The minimum of the range of pay level is determined to be competitive for employees who meet the minimum qualifications for the job;
- b. The midpoint of the range is the mathematical midpoint of the salary range; and
- c. The top of the range is the highest pay rate in a job grade. An employee whose salary has reached or exceeded the top of the range may receive an annual adjustment in salary based on merit up to the average percentage available to all staff employees on a University-wide basis.

The University's entire administrative and management team is responsible for the implementation and administration of the compensation program.
