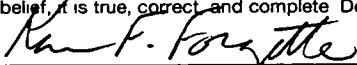

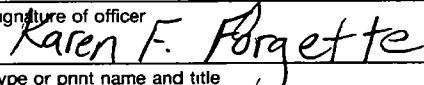

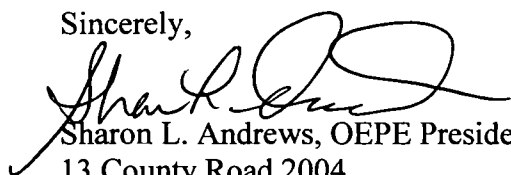
During a review of the financial affairs and charitable status of OEPE, our current treasurer Karen Forgette was advised by the IRS that OEPE was not exempt from filing and that OEPE had not filed annual tax returns in previous years. Our former treasurer had been advised that OEPE's income did not rise to the level to require filing. Once this delinquency was brought to our attention, our treasurer made every effort to expeditiously obtain the records necessary to prepare and file the appropriate tax forms. Nevertheless, we were unable to meet the filing deadline for this return.

OEPE is an all volunteer organization which solicits donations that are used for the sole purpose of providing grants to teachers for projects in the Oxford Mississippi Public School District. OEPE has no employees. Our income has historically been less than \$20,000 per year and is insufficient to hire an accountant to advise us in this matter.

we would also ask that OEPE be relieved of any obligation to file returns for prior years, as the accumulation of records and preparation of returns would pose a hardship both upon the organization financially and on its volunteers. We would submit that OEPE's funds and volunteer time should instead be expended to fulfill its purpose of assisting the Oxford Public Schools, especially in this time of dire education budget cuts in the state of Mississippi.
