The Foundation continues to be committed to funding collaborative research in the neurosciences at the Duke University School of Medicine as well as at other academic medical centers. Funded are principal investigators, postdoctoral fellows, and graduate students. The research is concerned with furthering the knowledge available as to causes and potential treatments for Alzheimer's disease and related neurological disorders. The Foundation also funds the Ruth K. Broad Seminar Series in Neurobiology and Disease, bringing noted scientists to Duke's campus throughout the academic year to share research findings and to promote networking among the scientific community. Results of grants awarded by the Foundation are shared through this program as well. Accomplishments were made in each of the three principal investigator level grants provided by the Foundation: (1) research advances were made in studying B-amyloid synthesis and clearance in cerebrospinal fluid, and were cited in a paper accepted in Annals of Neurology; (2) data sets were collected and analyzed to characterize how systematic inflammation is transduced to the brain and how inflammatory mediators in the brain influence neurogenesis from progenitor cells; (3) studies were done to investigate whether there is biological evidence for a role of RIM1a (a presynaptic plasticity protein) in enhancing cognition.
