HORIZON CHARTER SCHOOL IS USING A SYSTEM OF DATA-BASED DECISION MAKING TO IMPROVE THE ACADEMIC ACHIEVEMENT OF ALL OF OUR STUDENTS. WE DEVELOP PERSONALIZED LEARNING PLANS FOR EACH OF OUR STUDENTS USING CURRICULUM-BASED MEASUREMENT AND STANDARDIZED TESTING INFORMATION. WE ADMINISTER QUARTERLY BENCHMARK ASSESSMENTS ON MATHEMATICS AND ENGLISH-LANGUAGE ARTS AND TWICE YEARLY WRITING PROMPTS. THE RESULTS OF INDIVIDUAL STUDENT, PROGRAM, REGION, AND SCHOOL-WIDE PERFORMANCE ARE ROUTINELY ANALYZED USING A USER-FRIENDLY TOOL CALLED EDUSOFT. PERFORMANCE DATA FROM THE STAR CST, CELDT, CAHSEE, CAPA AND CAT 6 ARE ALSO INCLUDED IN EDUSOFT. OUR TEACHERS, PRINCIPAL, PROGRAM COORDINATORS AND DISTRICT ADMINISTRATIVE STAFF ANALYZE THESE RESULTS BY PERFORMANCE STRENGTHS AND WEAKNESSES. STUDENTS WHO PERFORMED IN THE BASIC RANGE ARE ENCOURAGED TO USE THE RECOMMENDED STRATEGIC INTERVENTION CURRICULA AND TO ENROLL IN SMALL GROUP INSTRUCTION. STUDENTS SCORING FAR BELOW BASIC AND BELOW BASIC ARE STEERED TOWARD INTENSIVE INTERVENTION CURRICULA AND/OR DIRECT INSTRUCTION CLASSES. WE ARE BUILDING A RESPONSE TO INTERVENTION SYSTEM INCORPORATING THESE AND MANY OTHER INTERVENTION STRATEGIES. WE SET ANNUAL SCHOOL-WIDE ACADEMIC ACHIEVEMENT GOALS IN MATHEMATICS, ENGLISH- LANGUAGE ARTS. A COMPREHENSIVE SCHOOL-WIDE CONTINUOUS IMPROVEMENT ACTION PLAN IS BEING IMPLEMENTED, MONITORED AND REVISED, AS NECESSARY, FOR EACH ACADEMIC ACHIEVEMENT GOAL. EACH DEPARTMENT, PROGRAM, AND REGION HAS ALSO SET ACADEMIC ACHIEVEMENT GOALS IN THESE THREE AREAS AND IS IMPLEMENTING TARGETED STRATEGIES TO ACHIEVE THEM. DUE TO THESE EFFORTS, HORIZON CHARTER SCHOOL DOUBLED THE REQUIRED GROWTH TARGET SET FOR 2007-08 BY THE CALIFORNIA DEPARTMENT OF EDUCATION. OUR SCHOOL GREW BY 10 POINTS ON THE API. FOR THE FIRST TIME IN THE SCHOOL'S HISTORY, WE HAVE SURPASSED THE 700 MARK REACHING A 2008 GROWTH API OF 707. ALL NUMERICALLY SIGNIFICANT STUDENT SUBGROUPS, EXCEPT FOR HISPANIC/LATINO STUDENTS, MET THEIR GROWTH TARGET SINCE 2003. HCS HAD BEEN IMPROVING ON ITS MI. OUR API HAS GROWN 65 POINTS OVER THE PAST FIVE SCHOOL YEARS WHEN COMPARED TO SIMILAR CHARTER SCHOOLS. HCS IS PERFORMING HIGHER ACADEMICALLY. HCS EARNED THE HIGHEST API OF NINE SIMILAR CHARTER SCHOOLS. THESE CHARTER SCHOOLS, MOSTLY ALSO NON-CLASSROOM BASED, HAD API SCORES FROM 609 TO 690. HERITAGE PEAK CHARTER, A SMALL INDEPENDENT CHARTER WITH 370 STUDENTS, HAD THE HIGHEST APT AT 704. ACADEMIC PERFORMANCE 2007-08 THE NUMBER OF HCS STUDENTS IN GRADES 2-7 SCORING PROFICIENT AND ADVANCED IN MATHEMATICS ON THE CONTENT STANDARDS TESTS (PART OF STAR), INCREASED FROM 23% TO 37%. THE NUMBER OF HCS STUDENTS IN GRADES 2-11 SCORING PROFICIENT AND ADVANCED IN ENGLISH-LANGUAGE ARTS (ELA) ON THE CONTENT STANDARDS TESTS SHOWED NO INCREASE REMAINING AT 43%. THE NUMBER OF HCS STUDENTS IN GRADES 10 AND 11 WHO PASSED THE ELA AND MATH SECTIONS OF THE CALIFORNIA HIGH SCHOOL EXIT EXAMINATION (CAHSEE) INCREASED AS DID TEST PARTICIPATION. WHEREAS WE HAVE MOSTLY IMPROVED ON STUDENTS' ACADEMIC ACHIEVEMENT, WHEN COMPARED TO ALL STUDENTS IN THE STATE, WE REMAIN LOWER IN ELA (BY 3%), LOWER IN MATH GRADES 2-7 (BY 6%) AND LOWER IN ALGEBRA 1 (BY 15%).
