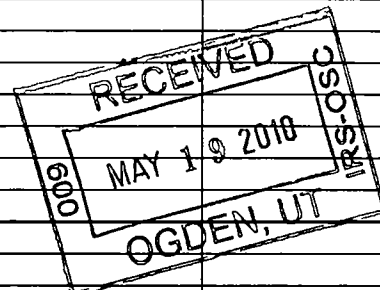

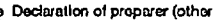

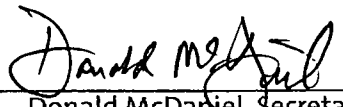
STATEMENT REGARDING UNDERDISTRIBUTION OF INCOME

During the fiscal year ended June 30, 2009, the Gay Noe McLendon Foundation (the Foundation) inadvertently failed to distribute the required amount of \$28,050. This mistake was discovered September 8, 2009, and the required distribution was promptly paid.

Each year, the Foundation uses the completed tax return to know the exact amount of the required distribution. This has proved to be a fool proof system in the past and has run smoothly up until this year. As such, the Foundation has consistently made the required distributions on time.

Pursuant to Internal Revenue Code § 4962, the Gay Noe McLendon Foundation respectfully requests that the first-tier § 4962 penalty for underdistribution of income, or initial tax of \$8,415, be abated because the underdistribution was due to reasonable cause and without willful neglect. Once the trustee of the Foundation learned of his mistake, the required distribution was paid immediately and he did not wait to act until the IRS issued a notice. The Foundation has never been late with their distribution obligations in the past. Being an exempt organization, they take these obligations very seriously and fully understand the consequences, of non compliance. However, the late payment of the 2007 distribution mentioned above was not intentional. The amount of the penalty \$8,415, is a significant amount for an organization, whose primary purpose is the support of charitable organizations. Therefore, the Foundation submits it is entitled to an abatement of the tax because it meets the requirements of § 4962.

I swear that this information is true and correct and that the foundation's underdistribution of income was inadvertent, accidental, and without intention or knowledge on my part or on the part of any of the Foundation's other directors.
