Schumpert Foundations primary purpose is to promote philanthropy and charitable giving to provide resources to enhance the ability of Christus Schumpert Health System in its mission of extending the healing ministry of Jesus Christ by providing for the communitys health needs. In furtherance of these purposes, the Foundation solicits and receives charitable gifts and grants to administer and invest and reinvest the same and to apply the whole or any part of the income and the principal exclusively for the benefit of the health care facilities, services and health community programs supported or operated by Christus Schumpert Health System within its service area in Northern Louisiana. The Foundation mails quarterly newsletters to over 3,000 names on our mailing list, which informs the recipients of the activities that the Foundation is involved in during the year. There is an annual associates campaign conducted from October 1-November 30 to encourage financial support for all Schumpert programs. During the holidays, we send out Christmas Joy brochures to encourage contributions to remember loved ones and business associates through memorials/honorariums. Public events are held throughout the year, such as Rhythm in Blues to benefit Womens Council of Sutton Childrens Medical Center and Run with the Nuns which benefits Cara Center for abused and neglected children. Christus Schumpert Health System has served residents of northwest Louisiana, southwest Arkansas, and east Texas for more than 100 years. Christus Schumpert is a 668 licensed bed faith-based health system providing acute care at two locations in the Shreveport-Bossier City area. The facilities are Christus Schumpert-St. Mary Place and Christus Schumpert-Highland. The health system also operates two stand-alone wellness centers, two urgent care clinics and a state-of-the-art cancer treatment center. Christus Schumpert Health System is part of Christus Health, which was formed in 1999 to strengthen the 130-year-old, faith-based health care ministries of the congregations of the Sisters of Charity of the Incarnate Word of Houston and San Antonio. Founded on the mission to extend the healing ministry of Jesus Christ, Christus is challenged to reach out to, and beyond, the more than 60 communities we serve to help those in need. Christus Health responds to the health care needs through services provided at more than 35 hospitals and long-term care facilities, as well as dozens of health care clinics, physicians offices, outpatient services, and community-based programs in Texas, Louisiana, Arkansas, Utah, and Oklahoma. Although programs may differ from facility to facility, each of our health care entities has the same objective which is to lead the way to a healthier community.
