	Duncan Regional Hospital (DRH) provides quality medical healthcare regardless of race, creed, sex, national origin, handicap, age, or ability to pay Although reimbursement for services rendered is critical to the operation and stability of Duncan Regional Hospital, it is recognized that not all individuals possess the ability to purchase essential medical services and furthermore that our mission is to serve the community with respect to providing healthcare services and healthcare education Therefore, in keeping with the hospital's commitment to serve all members of its community, Duncan Regional Hospital provides - consideration for free care and/or reduced rate care, where the need and/or an individuals' inability to pay coexists - care to persons covered by governmental programs at below cost - care to persons covered by governmental programs whose benefits have been exhausted - health activities and programs to support the community These activities include wellness programs, community education programs, special programs for the elderly, medically under-served, and a variety of broad community support activities Duncan Regional Hospital serviced 3,953 acute care inpatients, 263 comprehensive rehabilitative care patients, 432 skilled nursing patients, treated 32,708 patients in the emergency department, provided more than 70,000 outpatient occasions of service, 23,605 homecare visits, 22,267 Medicaid personal care and maintenance hours, and 5,219 hospice visits in 2008-2009 fiscal year Recognizing its mission to the community, Duncan Regional Hospital provides care to persons covered by governmental programs at below cost and services both Medicare and Medicaid patients In addition, Duncan Regional Hospital provides care at no charge or at reduced rates to patients unable to pay Charges for services not collected in 2008/2009 due to government programs, free or reduced rate services, and otherwise uncompensated care totaled \$103,653,017, representing over 56% of the hospital's gross patient service revenue Duncan Regional Hospital provides community benefit through free and minimum fee programs offered throughout the year based upon activities and services, which Duncan Regional Hospital believes will serve a bona fide community health need Such programs include Community Outreach (Broken Down by Duncan Regional Hospital Department) Duncan Regional Hospital - Duncan Regional Hospital collaborated with Integris Heart Hospital and hosted a "Women's Healthy Heart" luncheon During the event, 182 women received a body fat analysis, glucose and cholesterol level, and blood pressure checks A heart-healthy lunch, a free chair massage, and demonstrations on proper exercise techniques were provided as well To complete the luncheon, Dr Kris Mullins, Cardiologist, lectured on healthy food choices and lifestyle adjustments for a healthy heart - Duncan Regional Hospital donated \$1,000 to the Duncan Chamber of Commerce six-week fitness challenge - Duncan Regional Hospital contributed \$13,025 to the United Way Corporate Donation campaign This contribution was a 50% match of what the team members pledged to United Way during the campaign - Duncan Regional Hospital donated a billboard for the Duncan Rotary Club district conference The cost for the billboard was \$115 Rehabilitation Department - The rehabilitation department participated in the Health Careers program where twenty high school students participated and learned about careers associated with the rehabilitation department, what degrees are necessary and where to obtain those certifications - The rehabilitation department sponsored an educational program for the Duncan High School Educator Meeting where 50 people attended to learn more about sports medicine, personal fitness, and other various wellness topics - A Duncan Regional Hospital Wellness Center team member presented a program on the health benefits of massage therapy to 200 participants of the Women's Healthy Heart Fair - A physical therapist from the rehabilitation department presented a program on work safety and back injury prevention to 68 University of Oklahoma, Western Oklahoma State, and Cameron University students - The rehabilitation department sponsored the Sanford Sports Medicine Clinic with guest speaker, Dr Michael Bergeron of Sanford Health System in Sioux Falls, South Dakota Ninety-five area coaches attended the presentation where Dr Bergeron presented information on how to take care of their athletes by teaching them to maximize their performance using safe training habits - The rehabilitation department sponsored an eight-hour "Coaches Clinic" for approximately 65 high school area coaches on sports safety and training of athletes - The rehabilitation department collaborated with the Duncan Regional Health Foundation to offer a presentation on the benefits and techniques of pre-training for a triathlon - The rehabilitation department presented a program on sex education to 200 students during the annual Kaleidoscope event for area 7th and 8th grades - The rehabilitation department presented information on the importance of balanced implementation and treatments to 16 members of the Leadership Duncan Community Group Hospice - The hospice department sponsored a community outreach event where 59 people were instructed on advance directives Advance directives are the forms used to communicate health care decisions if a person becomes unable to express those wishes directly and are sometimes referred to as living wills - The hospice department sponsored two community remembrance services where attendees were able to honor the memory of loved ones with lighted candles Hands on Health - Hands on Health is an interactive learning center used to promote healthy lifestyle and health careers to area kindergarten through 8th grade students Tours are provided free to area schools throughout the school year, and in 2008, the center had approximately 3,300 students visit during 113 tours Education Department - The education department conducted training at Red River Technology on the importance of weight loss and exercise related to the development of diabetes Approximately 30 people attended the educational session - The education department conducted a two-hour presentation to 40 area students on careers in nursing - The education department donated time to work the "Fit Kids" event in conjunction with the Simmons Center Approximately 20 area students attended the presentation during the event - The education department provided diabetic screening and education to 23 people at the communities Compassion Free Care Center - In collaboration with the Cancer Centers of Southwest Oklahoma, the education department sponsored prostate screenings for 65 area men ages 40-80 This will be an annual event to help promote early detection in this population of patients - The education department provided an educational training on basic carbohydrate counting, serving sizes, and heart healthy meals Approximately 12 staff members from the Duncan Community Residence homes participated in the program to help offer higher quality therapeutic meals to their residents - The education department hosted the Safe Sitter program that had two sessions over the summer for students ages 11 to13 Safe Sitter teaches boys and girls how to nurture and guide a young child and how to handle emergencies when babysitting During this course they learn basic life-saving techniques, safety precautions to prevent accidents, CPR, how and when to get help, and tips on basic childcare There were 19 students who participated in these two classes - The education department sponsored an education session to 60 people of the Marlow Lions Club on heart health, prevention, and knowing your risk factors - The education department helped support the Southwest Oklahoma Blood Institute by donating the space for community blood drives Through the months of January - June, 137 community members and team members donated blood - The education department sponsored HealthLink, a telephone-medical information service staffed 24 hours/day, 7 days a week by registered nurses to the residents of Greater Stephens County The service handled 11,303 calls for the 2009 fiscal year at no charge to the callers Duncan Regional Hospital invested over \$50,600 in providing this service Radiology - The radiology department gave an informative seminar to 60 people about the department of radiology Surgery & Laboratory - The surgery and laboratory departments participated in the Red River Technology Center 8th Grade Career Expo by promoting surgical and laboratory careers to 200 attendees of the event The event encourages students to seek health related careers when selecting courses and options for their future Homecare - The Duncan Regional Hospital Home Care provided free monthly glucose and blood pressure screenings for senior citize
