


Educational courses, lectures, and workshops are offered in the fields of psychology, religion, expressive arts and the humanities. 200 courses and programs were offered during the Fall 2009, Spring 2009, and Summer 2009 semesters with 4,719 in attendance. The Jung Center sponsors outreach programs on site and at homeless shelters, community centers, medical facilities, and non-profit retirement communities. The programs include art class as well as yoga and other movement classes and are typically given for at-risk youth, senior citizens, mental health professionals, and persons with life-threatening diseases. Weekly sessions were held at community centers, one at a medical facility, and one at a non-profit retirement community. Five programs were offered on-site for mental health professionals.
