YWCA Women's Health Program - Established in 1994, uninsured and underinsured low-income women receive breast health care by accessing free mammograms, diagnostic screenings, and case management services In FY08-09, the YWCA provided services to 1,525 women In a 3-month follow-up survey - 100% responded they had a positive mammogram experience, - 82% indicated they are performing monthly self-exams- 65% have referred family and friends to the YWCA for services

YWCA Financial Empowerment Program - Established in 2004, the YWCA offers comprehensive financial education programs beginning with a 12-hour financial literacy class where women develop financial goals, spending plans, and effective savings habits, along with building credit and long-term assets Graduates of the class can participate in Individual Development Accounts/Matched Savings Program, in which the YWCA will match client's savings up to \$1,500 to purchase a home, start a business, or enroll in post-secondary education In FY08-09, 1,088 individuals participated in the Financial Empowerment Program Three months after graduation - 4 out of 5 graduates report an increase in savings or reduced personal debt- 3 out of 4 report having an easier time paying bills- 4 out of 5 report teaching their children financial literacy skills

YWCA Nurse-Family Partnership (NFP) - Established in 2006, first time, low-income mothers increase their parenting skills and the health outcomes of their children From early in pregnancy through the baby's second birthday, a registered nurse will make 60+ home-visits to help the mother prepare for a healthy baby, develop responsible and competent care for their child, and take steps toward self-sufficiency by developing a vision for their future Operating in 28 states, NFP is widely recognized as the most effective parenting education program in the United States In FY08-09, the YWCA provided programming to 247 mothers and families through the NFP program Families served through NFP achieve higher success rates than the Dallas County average on critical health and parenting indicators such as - Pre-term Birth Dallas County (13 5%)/NFP (9%)- Prenatal Care Dallas County (72%)/NFP (100%)- Subsequent Pregnancy at 18 months following first birth Dallas County (27 8%)/NFP (21%)- Immunization at 2 years of age Dallas County (73%)/NFP (91%)
