The purpose of Yellowstone Academy is to provide a high quality, faith based, private school exclusively serving children living in poverty in Houston, Texas. Yellowstone Academy opened on August 21, 2002, with four classes of three and four year old students. During the 2008-2009 school year, Yellowstone Academy served 256 students in grades PK 3 through fifth grade. Yellowstone is accredited by the Southern Association of Colleges and Schools (SACS).

Yellowstone Academy's mission is to exclusively serve children from families who are living in environments generally characterized as "at risk". The combination of illiteracy, dependency, and single parenthood define the cycle of poverty that these children are growing up in and are highly likely to repeat, absent effective intervention. Yellowstone's goal is to bring about radical change in life prospects.

It intends to reach children in circumstances that predict a high probability of life dysfunction and to provide them the tools and environment that leads to a high probability of life success.

The following is a summary of the student profile:

99% African American

Median family income is \$7,476.00

94% are children who live in single parent households

As a result of the factors of poverty, the majority of our children come to school language delayed, behind grade level, and at risk for failure in school. Yellowstone Academy's educational strategy has been specifically designed to address these challenges and is implemented with great success by a certified teacher and a

teacher's aide in each classroom. In addition, Yellowstone Academy employs an Executive Director, a Director of Education, an After School/Field Trip Director, a Social Worker, an Office Manager, a Parent Liaison, a Development Director, an Assistant Development Director, a PE teacher, a PE aide, a part time Music Teacher, a part time Art teacher, and two part time Bible teachers. Along with a large number of volunteers, these staff members work together to create an environment characterized by structure and discipline but also animated with hope and optimism. There is an excitement for learning. The school uses the best of published and teacher developed curriculum and emphasize methods and materials that are relevant to children in poverty and focus on active student involvement.

The parents at Yellowstone Academy are encouraged and given every opportunity to be an active participant in their child's education. With the exception of children in the custody of Child Protective Services, all families pay some level of tuition, which is scaled based upon their income. Parents in poverty are typically not comfortable in a school setting so a variety of strategies are used to create a strong, positive partnership between school and home. The school had 84% of the students return for the 2008-2009 school year and had a 95% retention rate during the 2008-2009 school year, something that is highly unusual for the population it serves.

As a result of the school's supportive and active board, Yellowstone Academy completed the construction of a gym in May 2009, providing facilities for sports and PE for the school as it expands through the eighth grade.

In May of 2009, Yellowstone Academy also graduated it's very first class of fifth graders, a definite reason for celebration!
