Summer internships for high school students and teachers have long been available at the Institute. A grant from the Howard Hughes Medical Institute allowed expansion of this program to foster supplements and improvements to the curriculum and to offer public lectures on scientific topics for the community. The goal of the Institute's education programs are to foster critical thinking, enhance science literacy and help train the next generation of scientists.
