	Gerald Champion Regional Medical Center (GCRMC) is the primary health care provider in Otero County and has been for over 60 years. The Medical Center is a 99-bed Acute Care Facility located at the base of the Sacramento Mountains in Alamogordo, New Mexico. The current facility, with its award winning design opened in December 1999 resulting in continued growth over the past ten years and subsequent expansions including a new Intensive Care Unit, additional Medical Office Building, and free standing Day Care Center. In addition, a new Medical Office Building and an Outpatient Surgery Center opened on the Medical Center Campus in January 2007. The Gerald Champion Regional Medical Center's primary market is the City of Alamogordo with secondary markets expanding to Tularosa, Holloman Air Force Base and Lincoln County. GCRMC shares a unique relationship with Holloman Air Force Base as the only hospital in the United States where active duty military personnel practice in a civilian hospital. This special arrangement allows one facility to meet the combined community and military needs, while serving as a model for the Department of Defense in the conserving resources. Our integration into the community is seen in our support of youth, civic and community activities. We are the largest civilian employer in Alamogordo employing approximately 650 people. The Medical Staff of GCRMC has 162 medical members consisting of 79 active members, 43 affiliate members and 40 Allied Health members. GCRMC continues to seek opportunities to expand services and improve quality, with the philosophy of not limiting its potential by the designation of "small community," but rather identifying its scope of service based on community needs. In 2005, GCRMC joined fewer than five percent of the hospitals across the country that had completed the Electronic Medical Record system. Computerized Physician Order Entry (CPOE) was completed with over 90% of our Medical Staff fully trained when the system went "live." Continued progress and expansion has enhanced GCRMC's commitment to strive for outstanding service and quality, acknowledging that its future is not in its buildings or technology, but rather its people. To this end we support the people of Otero County with our services and our financial contributions. Gerald Champion Regional Medical Center (GCRMC) has, since its inception in 1948, provided quality medical healthcare regardless of race, creed, sex, national origin, handicap, age, or ability to pay. Although reimbursement for services rendered is critical to the operation and stability of GCRMC, it is recognized that not all individuals possess the ability to purchase essential medical services and, further, that our mission is to serve the community with respect to providing healthcare services and healthcare education. Therefore, in keeping with GCRMC's commitment to serve our community, we provide free care and/or subsidized care, care to persons covered by governmental programs at below cost, and health activities and programs to support the community will be considered where the need and/or an individual's inability to pay coexist. Gerald Champion Regional Medical Center maintains records to identify and monitor the level of charity care it provides. These records include the amount of charges foregone for services and supplies furnished under its charity care policy. The amount of charges foregone, based on established rates, was \$2,013,820 for the year ended June 30, 2009. Gerald Champion Regional Medical Center views the position of sole provider as a significant commitment to the overall health and well being of the community. We are not satisfied with just providing healthcare, we are challenged by the opportunity to have a positive effect on the quality of life experienced in our community. With this in mind, we strive to facilitate and share opportunities to educate and motivate a philosophy of wellness. Our primary target is the disease process that we know can be eliminated or improved by changing or modifying human behavior. As with any community we serve a population that varies in its educational background. We strive to develop programs that target the needs and understanding of our audience. We utilize our physicians to provide open forums that present a topic followed by questions and time for individual discussion. This type of program is offered with a free lunch, educational materials, and if appropriate free screenings, such as glucose or blood pressure. There is an average of 90 participants in each of these seminars. The annual health fair serves approximately 375 community members. We augment the annual health fair with onsite mini health screening throughout the year. This is offered to businesses, civic organizations and churches with minimal to no charge. We offer free blood pressure screenings on a walk-in basis with educational materials in both Spanish and English. This allows us to address the high rate of hypertension in our community, its significant effect on other diseases, and an overall wellness picture. Gerald Champion Regional Medical Center partners with the American Cancer Society to offer the Look Good Feel Good program and the Gift Closet. The program has brought a highly valued service to our community. The Gift Closet provides free wigs, prosthesis, supplies, education and support to cancer patients and their families. GCRMC provides classroom space, supply storage and refreshments for weekly meetings. The opportunity to utilize our speaker's bureau is available to any organization in the community. A presentation can be prepared with limited notice to meet the needs of the organization. The wealth of knowledge in our organization allows us to create an appropriate fit for the requested need. At GCRMC, we feel it is important to embrace community needs that promote good citizenship. As an organization we support employee involvement in outside activities through contributions, dedicated time and sponsorship. Administration and staff members serve on community boards, dedicating many hours of support to those organizations. During fiscal year 2009 GCRMC administration and staff participated in 76 community projects with various organizations. The total civic contribution to the community by GCRMC was \$314,935 as compared to \$120,048 in the prior year. Our total civic in-kind contributions increased from \$78,445 in fiscal year 2008 to over \$163,520 in fiscal year 2009. We also recognized the positive effects of economic growth in the community by contributing \$5,250 to the Otero County Economic Development Council in fiscal year 2009.
