New Mexico Boys and Girls Ranch Foundation, Inc.

New Mexico Boys and Girls Ranch Foundation, Inc. is a nonprofit corporation that provides investment fund management, fundraising and financial support to the New Mexico Boys and Girls Ranches, Inc. (The Ranches). Our goal is to provide funding to The Ranches for the operation of multiple residential group care facilities, foster care placement, older child adoptions, parent training, family counseling services and new program development. (See Form 990 – New Mexico Boys and Girls Ranches, Inc. for more information about its services.)

We do not accept government funding or sponsorships from a national organization or church denomination. All contributions are a result of the support of generous individuals, businesses, corporations, civic organizations, foundations and a variety of churches.

Services Provided to New Mexico Boys and Girls Ranches, Inc.

Fundraising

Since we do not accept government funding or sponsorships, our fund raising efforts are especially important to operations. Our fundraising strategy consists of direct mail appeals, newsletters, an annual giving program, planned giving, grant proposals, capital campaigns and special events. Donor cultivation and donor relations are integral to these efforts.

We are members of the Evangelical Council for Financial Accountability (ECFA) and proudly display their seal on our publications. Our financial records are audited annually.

Investment Management and Reporting

Wells Fargo is our overall investment portfolio manager. They oversee the managers of each of our investment funds in compliance with our Board approved and monitored investment policy. Wells Fargo also makes quarterly performance reports to the Board. Our investments fall into three broad categories: Board restricted fund, permanently restricted endowment, and scholarships.

Board Restricted Fund. By resolution of the Board of Directors, planned gifts over a specific amount are put into an unrestricted investment fund. This allows us to grow the endowment and shield the children from times of financial uncertainty.

Scholarship and Education Funds. Scholarship and education funds are set up by contributors and are usually permanently restricted. These funds help children from The Ranches attend college or vocational school, and provide funding for Ranch schools. Donors receive an annual report showing the principal of their fund and the accomplishments made with the income.

Permanent Memorial and Endowment Funds. Permanent memorial and endowment funds are donor designated as a legacy in honor of a friend or loved one. A pictorial tribute and engraving program related to the funds is administered by the Foundation, and donors receive an annual report of principal and earnings. These funds are permanently restricted.

Planned and Deferred Gifts

Charitable giving through wills and trusts is attractive to many donors as a way of reducing estate taxes while helping their favorite charities. Our staff is available to answer questions and help interested donors include The Ranches in their estate plans. Estate planning services are offered to donors through a partnership with an Albuquerque law firm that specializes in estate planning. This partnership allows us to help more donors with their estates.

Charitable gift annuities are issued by the Foundation to donors who request them. A gift annuity is a contract between the donor and a charity whereby the donor makes a gift on the condition that they receive a predetermined rate of return (interest) on their gift for their lifetime. The donor also receives a current charitable deduction for a portion of the gift. We use charitable gift annuity rates suggested by the American Council on Gift Annuities. It is our policy to retain 100% of the face value of all gift annuities until the death of the annuitant.

Public Relations and Media

Visibility to the public is important to our ministry efforts. We maintain our visibility through commercials, newspaper interviews, speaking engagements, advertising, public service announcements and special events. This exposure helps attract people who are willing to help us fulfill our mission of helping children and families. This is critical since all contributions come from fund raising efforts.

Financial Philosophy

The effectiveness of our work is determined by how we handle our resources. For this reason, we adhere to a strong financial philosophy. We are committed to not going into debt, to growing an endowment to shield the children from times of financial uncertainty, and to starting new programs only when we are certain that they are needed. Our financial philosophy is further defined by the fact that we do not accept government funding or sponsorships from a national organization or church denomination. This makes us unique from other children's charities. However, it also makes fundraising more critical and expensive for The Ranches than for groups that don't rely as heavily on private donations.
