Tucson Centers for Women and Children has been DBA Emerge! Center Against Domestic Abuse since April 2008, when Brewster Center Domestic Violence Services merged with Tucson Centers for Women and Children Emerge! Center operates a 24/7 Crisis Line, two Shelters (Crisis and Transition), a Community and Children's program with two locations, a Transitional Housing program, a Child Care Center, a Children's Domestic Abuse program and a comprehensive Community Education program aimed at preventing future violence Emerge! provided 29,879 nights of safe shelter for 1,281 women and 645 children survivors of domestic violence, 3,267 hours of individual counseling, 1,730 hours of group counseling, and 130 domestic violence educational presentations to the community In addition, 26 families in the Wings of Freedom transitional housing program received a wide range of support services and 730 children received critical domestic violence education and prevention services to stop the cycle of violence
