Transitional Housing - 184 apartment units for families, couples and individuals are located in numerous sites throughout the city and county. Varying levels of case management are available to support those who are rebuilding their lives while recovering from homelessness, illness and/or upgrading their employment.

Work Force Development - Primavera's employment services assist homeless and near homeless adults learn new skills, enter or re-enter and succeed in the job market. Special emphasis is placed on job placement with ex-prisoners. A continuum of services including job counseling, case management, job search classes, and job placement assist over 900 individuals annually.
