What is the organization's primary exempt purpose? The mission of Catalina Community Services is to provide assistance to Greater Catalina residents to improve their quality of life. The vision is to be the resource center of choice with consistent services by volunteers to all residents of the Greater Catalina area.			
Describe what was achieved in carrying out the organization's exempt purposes. In a clear and concise manner, describe the services provided, the number of persons benefited, or other relevant information for each program title.			
28 Emergency Food Assistance-Catalina Community Services funds the food distribution through the Food Bank including the value of food donated to Catalina Community Services. On average 50 people received emergency food assistance each day the program was open. Clothing Bank-Catalina Community Services funds the clothing distribution program including the value of the clothing donated to this program. These donations make this program possible. Open only three days each week, on average 70 people per day shopped at the Clothing Bank. The Food and Clothing Bank programs have served more families than in the past. This past year over 275 area families were assisted through the programs of Catalina Community Service. This equates to over 1,300 people serviced in the Greater Catalina area. Senior Meals Program-Catalina Community Services funds the Senior Center and related items this past year. The number of seniors receiving home delivered meals or who chose to attend the congregate meals program continue to increase each year. Youth Programs Support-Catalina Community Services funds community based youth programming including funding a school wide Junior Achievement program, Catalina Community Services is a major supporter of the "Youth Day" celebration in Catalina. Expenses incurred during the holiday season (Christmas gifts, seasonal clothing jackets, hats, gloves, etc.) Community Radio-Catalina Community Services is a supporter of the concept of a "Community Radio Station" to serve the greater Catalina area. Catalina Community Services filled the role of agent for these grass roots driven efforts. All funds expended to assist this development process were raised by community volunteers on behalf of the proposed radio station.
