	Hospital Services - Overlake Hospital Medical Center is a nonprofit, independently operated regional center serving the eastern Puget Sound region with medical centers in Bellevue, Issaquah and Mercer Island. Founded in 1953, today Overlake Hospital is a regional leader in health care, providing advance medical services and excelling in the areas of cardiac care, general and specialty surgery, women's services, cancer treatment and services for the seniors. There were 21,887 patients admitted for inpatient medical care for a total of 74,933 patient days. There were 220,417 outpatient visits out of which 53,660 were for emergency care visits. The Hospital delivered 4,080 babies. Overlake Medical Clinics provided 73,623 patient visits. Overlake Hospital demonstrated a commitment to improving the health of the community by supporting many health-related events, programs, clinical research and made various contributions throughout the year that had a direct benefit to the community. The Hospital maintains records to identify and monitor the level of charity care it provides. These records include the amount of charges foregone for services. Overlake Hospital provided care to 2,643 patients who are uninsured or under insured in the amount of \$8,361,000 (estimated cost of \$3,340,000). The Hospital provided care to Medicaid patients at rates below the cost of providing services. The payments were less than cost by \$1,557,000. In keeping with the Hospital's spirit of giving back to the community it served, a total of \$5,226,000 of community benefit service activities were also provided. Overlake Staff spent an estimated 1,865 hours in the community by participating in, organizing and managing health programs and activities. Overlake is a hospital that's recognized for providing excellent patient care. In 2009 Overlake received Five-star rating from HealthGrades for Treatment of GI Bleed, Spinal Surgery and for Back and Neck Surgery. HealthGrades also awarded the hospital Maternity Care Excellence and Patient Safety Excellence. Premera Blue Cross accorded the hospital a Blue Distinction Center for Cardiac Care. The Commission on Cancer of the American College of Surgeons has granted Three-Year Approval with Commendation to the Cancer Center at Overlake Hospital. The hospital takes a leadership role in disaster preparedness and works closely with public health and safety agencies to coordinate care and serve as the back-up emergency response center for King County.

	Education Services - In addition to the excellent care we provide our patients, Overlake reaches outside our facility, offering free and low-cost classes for all age groups. Health education is an important part of wellness and preventive care. The Education Program provided 69,979 Family Contact Hours offering classes of a wide range of health related topics including women's health, prenatal care, coping skills, dealing with cancer, positive parenting, safety, asthma, heart disease, diabetes and healthy lifestyles.
