The Agros model is a uniquely holistic approach to alleviating rural poverty By providing long-term land loans to the poor along with integrated services such as community organization, training, and long-term credit, entire rural villages are empowered to become self-sustaining and escape the devastating effects of extreme poverty Program initiatives undertaken in FY09 included establishment of four new Agros communities in Nicaragua, Honduras and Mexico, expansion to a new region in Chiapas, Mexico in order to serve indigenous Guatemalan and Mexican families, and significant progress in monitoring and evaluation systems In addition, in September 2008 Agros was awarded a prestigious 2008 Development Marketplace Award, a competitive program organized by the World Bank to fund innovation in development
