The Foundation solicits contributions, grants and donations for the benefit of Souderton Mennonite Homes to further its charitable purposes. Grants from the foundation support the provision of benevolent care to needy persons residing in Souderton Mennonite Homes who can not pay for the care they receive. The purpose of Souderton Mennonite Homes is to plan, establish, operate and maintain housing for retired persons, the elderly, handicapped or otherwise disadvantaged persons, to provide elderly persons, on a nonprofit basis, with housing facilities and services specially designed to meet the spiritual, physical, emotional, social, and psychological needs of aging, and contribute to their health, security, happiness and usefulness in longer living, and to engage in programs, designed to promote and encourage the development and improvement of facilities for housing of retired, aging, handicapped and disadvantaged persons. Souderton Mennonite Homes accomplishes this purpose by providing housing, nursing, rehabilitation and other related services to community members through the operation of a 61 bed skilled nursing facility, 22 bed dementia personal care unit, 107 bed personal care unit as well as residential living apartments, cottages and villas.
