AT THE SHELTER THEY RECEIVE, SHELTER, FOOD, BASIC NEEDS, CRISIS INTERVENTION, CASE MANAGEMENT, INFORMATIONAL AND REFERRAL, LEGAL ADVOCACY, PERSONAL SUPPORT, AND EDUCATION AND SUPPORT GROUPS. A 24 HOUR CRISIS LINE IS ALSO ANSWERED IN THE SHELTER. DURING FY08 AWAIC SERVED 777 WOMEN AND CHILDREN IN THE EMERGENCY SHELTER AND PROVIDED 17,719 SAFE BED NIGHTS. ADDITIONALLY, STAFF PROVIDES 2,016 CRISIS CALLS AND 8,674 INFORMATION AND REFERRAL CALLS.
