Emergency Services/General Mental Health - JAMHI provides 24/7 on-call response with immediate screening and crisis intervention for mental health emergencies. These services are short-term, intensive psychiatric services provided to individuals during an acute mental health crisis episode. JAMHI also provides outpatient mental health services to adult members of the community. These services include individual and group focused/brief therapy.

Case Management - JAMHI case managers and clinicians provide community support for severely mentally ill adults through outreach services, as well as training in life skills that encourage independent living.
