Good Shepherd Medical Center served 2,277 inpatients and 42,583 outpatients in fiscal year 2008-9, as well as 16,183 patients in our Emergency Center. Although reimbursement for services rendered is critical to the operations and stability of Good Shepherd Medical Center, not all individuals have the ability to purchase essential medical services. In recognition of this, during 2008-9 Good Shepherd wrote off to collection 6,104,182 valued at charges foregone as bad debt. Direct charity care to our community amounted to an additional 4,924,211, valued at charges foregone. GSHCS provides care to persons covered by governmental programs at deeply discounted rates. Recognizing its mission to the community, services were provided to both Medicare and Medicaid patients. The unreimbursed value of providing care to these patients during fiscal year 2008-9 was 22,400,213 valued at charges foregone. Our Emergency Center is open around-the-clock to all community members, visitors, and travelers, without regard to one's ability to pay. GSHCS has an open medical staff, with privileges available to all qualified physicians in the region. GSHCS is governed by a twelve-member Board of Trustees. The Board is comprised of independent representatives of the community, with an emphasis on maintaining a true cross-section of core population communities within its membership. Good Shepherd Health Care System (GSHCS) is the corporate name for an organization made up of several entities, including Good Shepherd Medical Center, Vange John Memorial Hospice, TLC Home Health, Good Shepherd Medical Group, Good Shepherd Clinic Pharmacy, Good Shepherd Medical Foundation, and Good Shepherd Community Health Foundation. Good Shepherd serves a core population of almost 50,000 people in the city of Hermiston, Oregon and in 14 outlying smaller towns within a rough 50-mile radius. This population is largely rural, with agriculture dominating industrial enterprises. Our community benefits are communicated to the public through our Education, Public Relations, and Performance Improvement offices. Interaction with the community through surveys, conversation, and ties to community organizations gives us the input we need to adjust our mix of services as needed to serve the needs of our core population.
