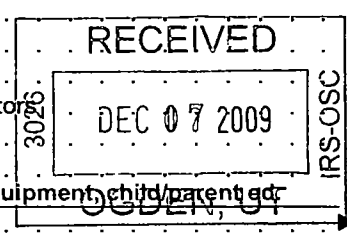

**Attachment to explain entry in Line 20: "Other changes in net assets or fund balances"**

In 10/2008 Brooklyn hired a professional bookkeeper to help clean up discrepancy between accounting software and actual bank numbers, and to clear out errors affecting accounting accuracy. Brooklyn's treasurers are volunteer and change every year or two, creating a cumulative error effect.

In an attempt to change the prior year's numbers as little as possible, many of the adjustments from the previous years were dated 7/1/2008. These can be accounted for on the 2008-2009 P&L. Some adjustments were not made with this in mind, and effect the numbers of other treasurer's years.

As of 10/2008, the accounting software accurately reflects financial activity and matches with the banks' numbers.
