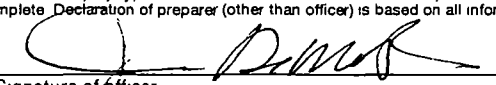

STABILIZATION SERVICES INCLUDED SEVERAL HOUSING PROGRAMS, PROVIDING PERMANENT HOUSING WITH CASE MANAGEMENT AND OTHER SERVICES TO VERY LOW-INCOME FAMILIES. SIXTY-SIX PERCENT OF ACTIVE PARTICIPANTS IN THE PEER SUPPORTED WORKFORCE DEVELOPMENT PROGRAM WERE EMPLOYED, AND 92% OF THEM INCREASED THEIR WAGES BY 25% OR MORE. THE SUCCESSFUL SOLUTIONS PROGRAM ASSISTED RECIPIENTS OF TEMPORARY ASSISTANCE FOR NEEDY FAMILIES (TANF) WHO HAD MULTIPLE BARRIERS TO EMPLOYMENT. IN THE FISCAL YEAR ENDED JUNE 30, 2009, 172 PEOPLE PARTICIPATED IN THE SUCCESSFUL SOLUTIONS TRAINING PROGRAM, AND 29,546 VISITS WERE MADE TO THE HELPING HANDS COMMUNITY STORE BY PEOPLE IN NEED OF CLOTHING.
