GSCHF raises funds and then grants scholarships to local students In this fiscal year the Scramble for Scholarships Golf tournament raised \$8,136 16 specifically to fund people in the community seeking health care careers In June 2009 the foundation awarded \$12,000 in scholarship funds to twelve students \$1,000 to a diagnostic imaging student, \$1,000 to a physical therapy student, \$1,000 to a dentistry student, \$1,000 to a Creighton University medical school student, and \$8,000 to eight nursing students GSCHF funds grants for local not for profit organizations that are in keeping with our mission to promote health and wellness \$35,645 in grants were made to six designated charities including Eastern Oregon University, Blue Mountain Community College, Vange John Memorial Hospice, Domestic Violence Service West End Project, Humane Society of Eastern Oregon and the Good Shepherd Community Health Foundation from the interest on a bequest from the late Mary Ellen Paul Other grants made by the Health Foundation this fiscal year include a \$5,000 grant to Agape House for covered storage of non-food donations \$5,000 was given to the Good Shepherd Community Wellness Coalition to assist with costs associated with hosting a Family Health and Fitness day on September 26, 2009 in Hermiston that will include activities, classes and events for all ages focusing on health, wellness and exercise A \$4,000 grant was given to the Hermiston Little League for the installation of safety netting over the bleachers and concessions at the Hermiston Field of dreams This netting was designed to improve the safety of players and spectators at the baseball complex \$3,500 Umatilla-Morrow Head Start - to assist in training community parents for the successful implementation of healthcare literacy and enable parents to become better caregivers by improving health care knowledge and skills \$2,619 To provide parents of disabled and special needs children access to services not readily available in rural and remote communities at no cost by coordinating and presenting four Orthopedic clinics, one Feeding Clinic and three Tone Management Clinics during the school year A \$2,500 Grant was given to the Hermiston School district to help fund this year's Outdoor Education program for fifth grade students \$1,513 to the Good Shepherd Wellness department and city of Hermiston to purchase rock needed to improve a walking trail for community members to access and use \$1,500 Stanfield Food Basket provides free food to low income people and families who meet the Oregon Food Bank guidelines \$1,000 to purchase books and encourage children to read in Umatilla and Morrow counties through the SMART program \$850 for Senior Fitness Academy The grant would be used to initiate a fitness program tailored to the needs of people 60 years and older The program includes health education, muscle strengthening and balance exercises as well as functional fitness pre and post tests to assess improvement \$750 for the Red Dress Luncheon titled "From a Woman's Heart" which helped to inform women about their risk for heart disease \$500 to the Hermiston Elks to assist with the purchase of a defibrillator for their facility GSCHF recognizes local citizens who give back to the community In December 2008, the Foundation sponsored the "Community Christmas Spirit Award " This award solicited nominations from the community of individuals who represent the Spirit of Christmas, the spirit of giving throughout the year Selected as the 2008 award winners were, Cliff and Judy Bracher In December 2008 we partnered with the Hermiston morning Kiwanis club and sponsored the Festival of Trees, raising \$9,218 38
