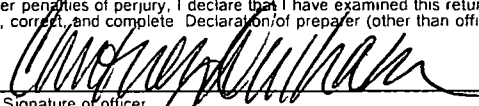

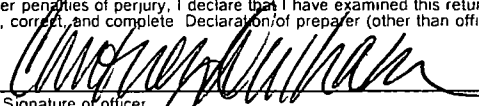

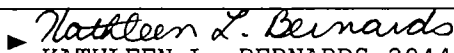

STATUS OF ORGANIZATION

The 2006 return for the Organization stated that it was a FINAL return, because the organization filed Articles of Dissolution with the Oregon Corporation Commission and distributed all of its remaining assets to the McMinnville High School Vocal Music Department as part of a grant in accordance with the Organization's mission statement. However, the Articles of Dissolution were not processed by the Corporation Commission, so the organization continued in existence. There was no financial activity through June 30, 2008, but subsequent to that date the organization has resumed the activities of its mission statement. So, it will continue to file information returns with the Internal Revenue Service.

This return was completed after the normal filing deadline of November 15, 2009. The organization requests a waiver of late filing penalties, since it is technically not required to file any return other than a 990-N due to its size. Form 990-EZ was prepared due to the organization's history and the information described above.
