TREATMENT FOSTER CARE SERVES VULNERABLE CHILDREN WHO ARE REMOVED FROM THEIR BIRTH HOMES DUE TO SEVERE ABUSE, NEGLECT, OR EMOTIONAL DISTURBANCE.
