Refugee & Immigrant Services - offers multilingual services to refugees and immigrants from Afghanistan, Iran, Bosnia, the former Soviet Union, Mexico, and Central and South America. Services include initial and ongoing resettlement, family support and child abuse prevention, specialized support for seniors, and assistance with navigating health care and other systems of care. Mental health services include individual, family, and group therapy sometimes addressing post-traumatic stress issues due to war and relocation.

4b (Code:) (Expenses \$ 1,048,599 including grants of \$ 86,182) (Revenue \$ 1,107,253)
Parenting & Youth Services - provides mental health services for underserved children and their families, including home-based intervention and ongoing case management for children ages 0-7. Provides mental health consultation services to numerous preschool sites, helping teachers, administrators, and parents to effectively assist children and their families. The agency's early childhood staff has expertise in responding to children exposed to domestic and community violence, trauma, and neglect.

Older Adult Services - provides resources and support to older adults and their families, including case management, counseling, family intervention, support groups and educational workshops. Also provides specialized services to Holocaust survivors. Older Adult Services works with older adults and their family members to preserve independence and allow people to age in dignity in their own homes.
