Upon review of our records and the stated filing requirements, we have determined that our organization did exceed both the asset filing level of \$10 million and the return filing level of 250 returns for the prior calendar year. Because of never having previously been required to file such a return, and due to the possible confusion as to which calendar year return filing numbers are to be considered, we inadvertently overlooked this change in our filing requirements. We respectfully request that any potential late filing penalties for such omission be waived for reasonable cause in this situation. We addressed and filed the required electronic version of the tax return as soon as we became aware of the situation, and have always otherwise filed all tax returns timely. This failure to file was simply a case of inadvertent oversight of this required change.
