THEY ADVOCATE FOR EQUAL EDUCATIONAL OPPORTUNITY FOR EVERYONE IN THE MARIN COMMUNITY AND SUPPORT STUDENTS IN NEED TO SUCCESSFULLY PURSUE AND COMPLETE HIGHER EDUCATION. SINCE OUR FOUNDING IN 1981, MARIN EDUCATION FUND HAS DISTRIBUTED MORE THAN \$45 MILLION IN FINANCIAL ASSISTANCE TO MORE THAN 30,476 MARIN RESIDENTS. MARIN EDUCATION FUND HAS BEEN A SUPPORTING ORGANIZATION OF THE MARIN COMMUNITY FOUNDATION SINCE 1986.
