Immigrant Organizing, integration and Leadership Development CHIRLA works with a base of over 1,500 low-wage immigrant workers in the underground economy, empowering them to build a mobilized base of immigrant rights activists CHIRLAs work with day laborers created a nationally replicated model for day laborer organizing, which became the National Day Labor Organizing Network (NDLON) CHIRLAs started the first Day Laborer Centers, helping this population assimilate through access to employment, education on workers rights, and a much-needed safety net CHIRLAs work organizing domestic workers led to the founding of the statewide California Household Worker Rights Coalition, and later the National Domestic Workers Alliance The Leadership Development component of CHIRLAs programming reaches almost 1,000 immigrant adults and youth each year through its Wise Up!
