OUR VISION OF A COMMUNITY IS ONE WHERE YOUNG PEOPLE ARE TRULY SEEN AND NOT JUST WATCHED, WHERE SOCIETY UNDERSTANDS AND ACCEPTS ITS RESPONSIBILITY IN MEETING THE NEEDS OF ALL YOUNG PEOPLE AND WHERE YOUNG PEOPLE BRING THEIR GIFTS BACK TO THEIR COMMUNITIES AS PRODUCTIVE MEMBERS OF SOCIETY.
