Attachment to Part II – Balance Sheets

The Boris Lurie Art Foundation (the "Foundation") was formed in Liechtenstein in 1991 as the Stutzpunkt Stiftung. In 2009, after Boris Lurie's death, the Foundation changed its name, applied for recognition of exempt status in the United States and its status as a §501(c)(3) private foundation was recognized in a determination letter dated May 22, 2009. Therefore, the Foundation's initial return shows a beginning balance sheet as of May 22, 2009.

Reason for amending return

The Foundation filed its initial return, a 2008 Form 990-PF, for the tax year of 7/1/08-6/30/09. The Foundation is a foreign organization which did not receive recognition of U.S. exempt status until May 22, 2009. The Foundation, therefore, is amending its previous filing for the year ended 6/30/09 (a 2008 form) with this filing (a 2009 form) for the year ended 6/30/09, but beginning on 5/22/09.
