Registered Volunteer program (which was implemented as a background screen program to help ensure a safe environment for USBC youth members), lane certification and year book expense (totaling \$4,512).

Line 1f = dollars received as a direct by-product of the tournaments we are required to run by headquarters each year. At the end of the year, dollars are presented to the charities.

At the annual meeting the audited financial statements along with a copy of the 990 is presented to the membership. At that time, should there be adjustments required, an amended 990 is filed. After review is completed a copy of the 990 and/or any other documents are available via request on the website and/or phone call to the office.
