THE OHIO OPERATING ENGINEERS EDUCATION AND SAFETY FUND WAS ESTABLISHED TO PROVIDE SCHOLARSHIPS, SAFETY TRAINING PROGRAMS, EQUAL EMPLOYMENT OPPORTUNITIES AND OTHER WORK-RELATED SUBJECTS FOR THE BENEFIT OF ELIGIBLE EMPLOYEES AND THEIR FAMILIES, AS DETERMINED BY THE BOARD OF TRUSTEES.
