Every athletic coach is encouraged to submit a grant request to the Boosters organization in April of each year. These requests are for equipment, supplies, and other expenses which are not covered by the CMHS Athletic Department budget. The Boosters Board evaluates each request and allocations are made based on the merit of the request and the funds available in the general Boosters operating account. Every Boosters member is invited to attend the meeting and provide input toward the final decision.

4b (Code: _____) (Expenses \$ 9166 including grants of \$ 0) (Revenue \$ 0)
Boosters manages the concession stands for all CMHS sporting activities. All teams and their representatives actively participate in the staffing of these stands throughout the year. The profits are divided between the working team and the general fund. The working teams uses these discretionary monies to fund coach requests for equipment, supplies, transportation, etc. The Booster's allocation is divided at the end of the year among the athletic teams depending on their grant requests and available monies (see 4a, above). The amount of \$9166 represents the amount that was distributed to the individual working team accounts.
