Incorrect Valuation of Assets

Statement 12

The imposition of the Section 4942 tax on undistributed income allocable to the 2007 tax year was solely the result of an incorrect valuation on the 2007 tax year 990-PF, which has since been corrected on an amended 2007 tax year 990-PF filed on March 15, 2010. The valuation error was the result of an accidental transposition of numbers in the calculation of the fair market value of the assets. The error was not willful, and it will be corrected in the manner provided under subsection 4942(a)(2), as described below.

In accordance with the requirements of subsection 4942(a)(2), the foundation will distribute the amount of the undistributed income from the 2007 tax year within the allowable distribution period, and the foundation will notify the Secretary that such amount has been distributed. Furthermore, the foundation will file an election under subsection 4942(h)(2) with the Secretary to treat such distribution as made out of the undistributed income for the 2007 tax year, which is the year for which a tax would have been imposed under subsection 4942(a).

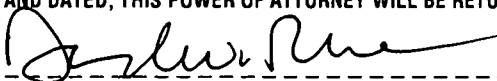

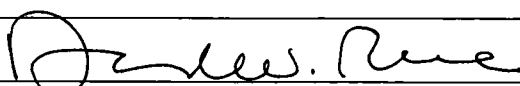
