THE ANNUAL CAMPAIGN WAS OUR LARGEST PROGRAM FOR THE 2008-2009 SCHOOL YEAR. THE CAMPAIGN RAISED \$528,626. THE FUNDS WERE USED IN THE FOLLOWING PROGRAM AREAS: LOWER SCHOOL OPERATIONS, MIDDLE SCHOOL OPERATIONS, UPPER SCHOOL OPERATIONS, SCHOLARSHIPS, ATHLETICS, FINE ARTS, AND PARENTS ASSOCIATION. THESE FUNDS WERE RAISED THROUGH SOLICITATION BY PHONE AND MAIL. THESE PROCEEDS TOUCHED THE LIVES OF 1,070 STUDENTS AND 160 FACULTY AND STAFF MEMBERS, NOT TO MENTION THE 700+ FAMILIES INVOLVED IN THE SCHOOL.

THE PARENTS ASSOCIATION IS THE SECOND LARGEST SERVICE PROGRAM. IT IS A PARENT VOLUNTEER GROUP THAT SUPPORTS THE OPERATIONS OF THE SCHOOL. SOURCES OF REVENUE ARE \$20,000 FROM THE ANNUAL CAMPAIGN AND THE NET PROCEEDS FROM THE DISTINGUISHED SPEAKER LUNCHEON EVENT WHICH TOTALED \$282,254. THE PARENTS ASSOCIATION HAS EXPENSES FOR THE FOLLOWING: ORGANIZING THE PARENT SCHOOL COFFEE AT THE BEGINNING OF THE YEAR, PROVIDING TEACHER APPRECIATION LUNCHESES, PURCHASING COFFEE FOR THE SCHOOL LOUNGES, TEACHER CHRISTMAS BONUSES AND PRINTING THE SCHOOL DIRECTORY. IN ADDITION, IT IS THE UMBRELLA ORGANIZATION THAT HOUSES ALL PARENT VOLUNTEERS.

THE EAGLE ATHLETIC BOOSTER CLUB IS OUR THIRD LARGEST PROGRAM. THE EABC RAISES MONEY TO SUPPORT THE ATHLETIC PROGRAMS AT SECOND BAPTIST SCHOOL. REVENUES TOTALED \$126,273 AND CAME PRIMARILY FROM THE FOLLOWING AREAS: CONCESSIONS, MEMBERSHIP, MERCHANDISE, HOMECOMING, SPRING SWING, FLIGHT NIGHT, YARD SIGNS. NET INCOME OVER EXPENSES WAS GRANTED TO THE SCHOOL ATHLETIC DEPARTMENT TO PAY FOR UNIFORMS, EQUIPMENT, AND PLAY-OFF EXPENSES.
