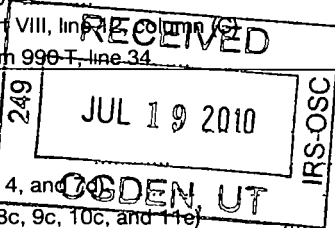

To foster, develop and encourage such agencies as will best promote the welfare of this community. Establish and maintain a central Jewish fundraising organization in the community. A curriculum of art, music, math, science, and other activities provided as a group and independently for preschool aged children. Enrollment in 2009 was 64 children.
- c.) Youth, adult, and senior recreational activities. Activities such as vacation camp for children, enrichment classes for children, adult basketball, senior luncheons, Eldersize classes, youth sports, youth chorus, and various other programs. Approximately 400 individuals participate.
- d.) Campaign Allocations - the Organization conducts an annual fundraising campaign and the contributions, after deducting fundraising expenses, are distributed to various Jewish organizations.
- e.) Other Program Services - Jewish Family Services and Meals on Wheels - provides services to community including approximately 4300 meals served to the elderly or disabled.
