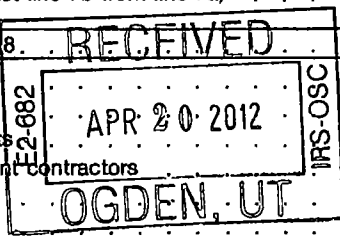

including math and science, and will meet the highest international certification standards as set forth by the

International Baccalaureate Organization, the Council of International Schools, and the Southern Association of Colleges

and Schools.
