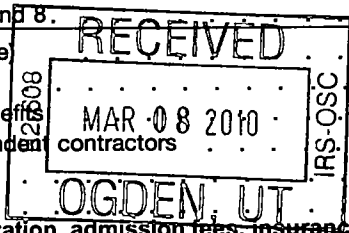

Live It Learn It missed the deadline for requesting an extension. We are a small organization with few employees and no paid accountant. We have, however, recently found an accountant who will be advising us on a pro bono basis to ensure that all future forms are submitted in a timely manner. Given that we operate on a very limited budget, we request an abatement of late fees. Please note that we are filing well within the extension period.
