The Academy sponsors a Fellowship Program which offers Masters and Doctorate Degrees in Research. The Masters is a two-year program, and the Doctorate a four-year program. The programs require extensive hands-on work in the lab, where new, environmentally responsible technologies are developed. Average annual enrollment is currently maintained at 25 students, with all the students on research fellowships. During the year the International Academy of Science has maintained a dedicated connection to the Internet and a registered domain name, science.edu, thereby providing Internet access to the faculty and students. The Internet access has been a valuable research tool at the Academy.
