Hospice Fund - Halifax Regional Hospice is the recipient of many generous donations from the community memorializing or honoring family and friends. Funds raised through donations are used to support unfunded patient care, the volunteer and bereavement programs, staff, patient and family education, marketing and educational materials and special projects such as the C A R E Channel for hospitalized patients, the labyrinth in the Healing Garden and items such as CDs and DVDs used in music therapy. Hospice funds also pay the salaries of a part time chaplain and a part-time bereavement coordinator. Hospice does not discriminate on the ability to pay. In FY09 Hospice received contributions of \$78,232. Disbursements in FY09 totaled \$88,942.

Halifax Regional Community Partnership Program - As a cornerstone organization in our region, Halifax Regional takes seriously its responsibility to be an active corporate citizen. The Health System contributes to various organizations that share its mission to promote good health and wellness and to help improve the quality of life of all ages. As part of the Health System's continued active community involvement, the Halifax Regional Community Partnership Program was established in FY05 to enable Halifax Regional Health System to maximize its resources to provide the greatest benefit to citizens in Southside Virginia. Guidelines for requests help answer important questions that enable the program to disperse resources in the most effective manner. In FY09 \$53,481 was donated to support community programs in our service area. Additionally, hundreds of health education brochures and giveaways were provided to community organizations to help support their events and programs.

Project PRIME Scholarship Endowment Fund - Project PRIME ((Public Rally for Individual Medical Education), begun 26 years ago with contributions from individuals and businesses in the area, provides financial assistance to those in the region who want to pursue a career in a healthcare or a healthcare-related field. In FY09 approximately \$47,867 in scholarships was awarded to 44 students pursuing nursing education and 18 people entering clinical and/or business education programs (Scholarship applications are available on Halifax Regional's Web site, beginning in January of each year, for those in the region who have been accepted into accredited educational programs and who desire financial assistance to pursue their studies.) Project PRIME is administered and promoted by Halifax Regional Hospital.

This program is administered through the Halifax Regional Development Foundation, Inc. During FY09, 1,120 patients received medications valued at \$2,198,785.28. Expenses \$39,527, Grants \$0, Revenue \$23,542. Jesse J Bates Scholarship Program - This program was started in 2002 in honor of Dr. Jesse J Bates, one of twelve physicians on Halifax Regional Hospital's medical staff when the hospital opened in 1953. In FY09, the Bates Scholarship provided \$12,000 in scholarships to six graduating high school seniors from the Halifax Regional Health System service area. The purpose of the scholarship is to encourage high school seniors to seek education to fill critical healthcare vacancies and acquire skills for use with technologically advanced equipment and treatment therapies. The scholarship endowment fund receives donations from the community and the late Dr. Bates' family. This scholarship is administered and promoted by Halifax Regional Hospital. Expenses \$12,000, Grants \$12,000, Revenue \$3,192.
