A majority of the Fund's grants are made to support the programs and facilities of the Winship Cancer Institute at Emory University. In the past year, Winship received Cancer Center designation by the National Cancer Institute. Fund grants were used to recruit and retain faculty for dual appointments at Emory's medical school and the Winship Cancer Institute and to fund significant faculty research projects in cancer prevention, detection and treatment.

Fund grants supported over 40 academic initiatives in the medical institutions that make up Emory's Woodruff Health Sciences Center, including 14 new initiatives for this fiscal year. New initiatives focused mostly on developing Emory's Center for Comprehensive Informatics. Additional support was provided for Emory's Predictive Health Initiative and centers in clinical and translational sciences, heart and vascular medicine, neurosciences and palliative care.
