We expanded our Master Playwright Series and launched new educational initiatives. The series gave public presentations of lectures and staged readings of 3 established playwrights and included local university student-directors assisting in the preparation of the series.

Our new educational initiative was a collaborative effort with non-profit ASPEN THEATRE MASTERS creating a new two week play festival entitled "New Bridges Fest" featuring emerging playwrights from across the country, linking them with other veteran theatre artists and producers and professionals. This workshop featured talk-back discussions with the playwrights, directors, and actors after the presentation of the plays.
