The Canadian River Cattle Company, L P (the Grantor) has granted the Foundation in perpetuity conservation rights to a tract of land in Oldham County, Texas. The easement, which is the right afforded to another person to make limited use of another's real property, was granted to the Foundation in order to preserve the natural, scenic, open space, historical, cultural and educational values of great importance to the Grantor and the people of the State of Texas. The terms of the agreement state that the conservation values of the property should be preserved and maintained by permitting only those land uses on the property that do not significantly impair or interfere with ranching, hunting and fishing activities. The easement was recorded at date of grant at an estimated fair value of \$8,000,000.
