In 2009 the Audrey and Martin Gruss Foundation (the "Foundation") (EIN 90-0445575) received the assets of and assumed the operations of the Audrey and Martin Gruss Foundation (the "Trust") (EIN: 13-3132987). The Board of Trustees of the Trust determined by unanimous written consent that it would be prudent to incorporate the Trust's operations. The Foundation was formed on January 22, 2009 and was approved by the IRS on March 20, 2009 as a tax-exempt private foundation under Sections 501(a), 501(c)(3) and 509 of the IRC. The Trust transferred all of its assets and liabilities to the Foundation on August 31, 2009, which assets consisted of cash and securities valued at \$83,596,593. Following the transfer to the Foundation, the Trust ceased operations. The Trust timely filed its final Form 990-PF reporting the transfer of all of its assets and liabilities and the termination of its operations. This return is the Foundation's initial tax return.

Because the Trust transferred all of its liabilities, operations and tax attributes to the Foundation, the Trust is not required to exercise expenditure responsibility on the distribution to the Foundation, as the transferee is treated as the transferor. The Trust's remaining distributable amount of \$1,833.052 at August 31, 2009, as shown on Part XIII, line 6(f)(d), will be distributed by the Foundation in a timely manner.
